



Sentencing Hearings Announced

The Geneva County District Attorney's Office has announced several recent sentencing hearings held in the Geneva County Courthouse.

Grady White Sent to Prison

Grady White, 35 of Slocumb, pled guilty to 6 counts of breaking and entering vehicles and one

count of theft of property 2nd degree and one count of receiving stolen property 2nd degree and received 95 months in prison. Grady White applied for probation which was considered by Judge Quattlebaum on November 21, 2006. Judge Quattlebaum denied White's application for probation and remanded him to the custody of the Sheriff to serve his sentence with the Department of Corrections.

Smith Goes to Prison for Production or Porn

Kenneth Wayne Smith, 58, of Geneva who was found guilty in September by a Geneva County Jury of three counts of producing obscene material containing visual reproduction of persons under the age of 17 (production of porn) which is a Class A felony was sentenced on November 21, 2006. Smith was sentenced by Judge Quattlebaum 10 years in prison on each

count and his sentence was split to serve two years. Smith's Counsel requested probation and an appeal bond which were both denied by Judge Quattlebaum. Smith was remanded to serve his sentence and gave notice of his appeal continuing to claim his innocence. Chief Assistant District Attorney Bill Filmore spoke on behalf of the State during the sentencing hearing and asked the Judge to consider the loss of innocence of these

three little girls ages 9-10 in rendering his judgment on the sentence.

Andrew Newsome to Prison on 10 Year Sentence

Andrew Newsome, 45 of Enterprise, who pled guilty on October 16, 2006 to Robbery 2nd Degree was denied probation by Judge Quattlebaum on November 21, 2006 and remanded to the custody of the Sheriff to serve his sentence with the De-

partment of Corrections.

Raymond F. Pierce Pleads to Rape Second

Raymond F. Pierce, 49 of Enterprise, pled guilty to Rape 2nd Degree for having sexual intercourse with a girl under the age of 16 years old. Pierce pled to a 3 year sentence before Judge Quattlebaum on November 21, 2006 and made application for probation which will be heard after his probation report is completed.

Slocumb Receives Grant to Replace 1930's Sewer Line

A state grant to replace one of the main sewer lines will help keep rate increases to a minimum.

Slocumb was awarded a Community Development Block Grant for Community Enhancement of \$250,000 to replace the sewer lines on Washington, Foster and Slocumb streets.

"This grant was the key to keeping any rate increase to a minimum," said Guy Miller, utilities director.

Miller said the town has been working to find funding for this project for seven years. This was the first year the town was able to apply for this type of grant.

"It is one of the oldest sections of town and one that drains a major portion of the central part of town, including city hall and the fire station and Alatech," he said. "There is on-going problems especially with heavy rains when sewer lines get backed up."

The grant will replace old concrete pipe. "The pipe has become too deteriorated to repair," he said. "Slocumb was one of only a few towns to receive a community enhancement grant for a rehabilitation project."

The local match will be \$25,000 and be paid through the Water and Sewer Board. Miller said the board has not raised water or sewer rates in eight years.

He said there are three sections of town that need to have major work on the sewer system. One is at the wastewater treatment plant. But there are not grants available to pay for the work there, he said.

Mayor Vickie Moore said the grant will eventually benefit about 300 residences.

"We are having a great year," she said of the grant announcement.

Slocumb was awarded a housing rehabilitation grant to upgrade about 20 homes along South Kelly Street. "The paperwork has been submitted by the landowners," she said. "They are waiting for word from the Southeast Alabama Regional Planning and Development Commission to begin the work."

The estimates were low enough that she hopes the target area may be expanded.

"I talked with the council at the last meeting (Nov. 20) and they agreed for me to ask if we could add more homes," she said. She will contact the Alabama Department of Economic and Community Affairs, the state agency that approved the grant, to see if the zone area can be amended.
