5-4-05

-Governor Bob Riley visits Geneva on Tuesday, May 10. Governor Riley made a special trip to Geneva for a groundbreaking ceremony of Sysco Systems of the Gulf Coast.

2005: Geneva County Commission Deals with Numerous Issues that Result in Controversy

The Geneva County Commission was dealt with many different issues during the past year. So many issues that a top 10 was created for them.

10. Larry Everett pulls rocks out of his pocket during a meeting earlier in the year - Everett said that he was giving the commissioners actual stones to throw for once. The incident took place during discussion on the hiring of an employee who was hired by County Administrator Donna Jones

9. County Audit Is Better - After a terrible audit during 2004, the 2005 audit proved to be much better for the county.

8. Fail(ed) System - The commission has recently learned that the heating and air system put into the county jail in 2004 is now working properly. The system was put in by Fails Heat and Air in Dothan.

7. Budget Woes - The commission had four separate motions before they agreed on a budget this upcoming year.

6. Pretrial Diversion Bill Almost Held up by Commission - The commission voted 3-1 to approve a pretrial diversion program that was being requested by District Attorney Kirke Adams. The problem seemed to be the fact that the lone no vote, Commissioner Larry Everett, might be enough to keep the bill from being passed by Senator Harri Anne Smith who

requires a unanimous vote for items presented to her. The item eventually passed.

5. Jail Overcrowding - Jail overcrowding has been a big concern for Sheriff Greg Ward now for many years. The problems have intensified in recent years and the issue finally took center stage in 2005. The end result appears to be the temporary structures approved by the county commission and a plan in the works to put a tax referendum on the ballot for the 2006 general election.

4. Hospital Issues - The county commission dealt with issues of who to select to the Geneva County Hospital Authority Board after the Authority sent the commission a revised plan that would not allow the commission to have the

final say on appointments.

The matter led to several discussions between the two groups, concerned citizens and even the Geneva Mayor and City Council. The situation has since been changed to meet the satisfaction of the commission and the authority.

3. Adkison Refuses to Allow Bauman a Chance to Speak - Geneva resident Bill Bauman was denied the opportunity to address the county commission three times about his concerns over the Geneva County Health Care Authority Board.

2. Drug Policy Problems - County Administrator Donna Jones hired an employee for her office after giving them a second drug test. The second test was given after the individual

failed the first test. The employee has since quit but the issue created quite a stir that resulted in the drug policy being made tougher.

1. Igloos Anyone - The county commission approved placing domed temporary jail facilities on the grounds of the Geneva

County Courthouse to deal with jail overcrowding. The decision was a 3-2 vote with Probate Judge Harry O. Adkison, Commissioner Larry Everett and Commissioner Gary Shields voting in favor of the facility while Commissioners Ray Minshew and Fred Hamic voted against the plan.

I Remember Papa and the Christmas Express

It was a cold and damp day, the sky overcast from a canopy of gray cloud cover. It was December 1949 in Samson, Alabama. I was four years old and my maternal grandfather, Willie B. Hoffman, "Papa" informed me that he was taking me on my first train ride far away to the City of Geneva to see the arrival of Santa Clause.

It was early that eventful day as he took my hand and pulled me up to the boarding area at the Samson depot. I was initially apprehensive of what appeared to be a huge, monstrous mass of black metal, hissing steam, bellowing white smoke, clanging bells, and loud whistles. I became aware this was the iron horse that was to whisk me away to Santa Land. The whistle blared loudly in my ears. Papa assured me that

everything was alright. He would talk with me softly, providing me with the details of our trip that day. He told me that the railroad passenger service between Samson and Geneva was short-lived and would soon, "belong only to the ages".

We boarded the warm comfortable cabin car and I was escorted to a window seat. There I observed the activities within the depot. The conductor yelled, ALLLLLLLLA-B-O-O-OA-D!"

We were soon inching away from the station, slowly moving at first, jerking and chugging down the tracks. Within what seemed like seconds, we were rolling past southern pine trees, cows grazing in pastures and mistletoe laden oak trees. Abruptly, the terrain was flying past my window as the train accelerated to break neck speed. The sounds of the wheels were heard singing clickity-clack,

clickity-clack, clickity-clack, clickity-clack, click-click. I marveled at the sights outside my window. Papa held my hand tightly as we raced down the twelve-mile ribbon of steel to Geneva. Green flashes of tree moss danced outside as splotches of gray from the Spanish moss hanging from the trees growing through a gray pond quickly dashed past my eyes within the blur of light.

I was a bundle of eyes and ears as the train started to slow and we eased to a stop at the Geneva station. The hissing white clouds of steam reappeared and the conductor, announced loudly, "GEEEE-NEEE-VAH!" Papa explained we needed to walk to the street where Santa would be arriving. He gingerly dragged me from the depot and I found myself street side with many grown-ups. Some of the men were dressed in white shirts

and fedora hats, others had various types of work clothing. Rudy faced children laughed and screamed with excitement, their breath casting clouds of vapor into the chilly air. The women wore different patterns of pokadotted dresses, funny looking hats and interesting leg hose. The hose had black lines down the back of women's legs. Papa placed me directly in front of the street just as the main man himself appeared to my left, riding on his crimson and white float. He was all decked out in his bright red suit complete with his white fully hair and beard. His helpers, donned in green outfits accompanied him throwing candy to the crowd. Suddenly, he looked straight at me and winked!

I hadn't caught my breath from this experience before I was back on the train and returning to Samson and pulling into the depot upon

our return. As I reflect upon this experience, I realize the most precious memory of that day was the time, knowledge and love provided to me by my beloved grandfather. This fascinating pre-Disney trip through an earlier South included the enchantment of Christmas and Santa, however, the magic was within my grandfather's love. He will always be in my mind, heart and soul at Christmas and always.

Notes: Papa was within his seventh decade of his life at that time. He lived to the age of one hundred and two years and passed on at the Masonic Home in Montgomery, Alabama on August 5, 1981.
