## Three major arrests made in Geneva County

Law enforcement throughout Geneva County made hree major arrests last week, including felony charges of sexual abuse and assault.

Capt. Ricky Morgan of the Geneva Police Department reports that on Friday the Geneva Police Department Criminal Investigation Division arrested William Lloyd Cotton, 39, from Geneva and charged him with sexual abuse 1st and three of counts possession child of pornography.

Morgan said that the investi-



gation involved a female juvenile who alleged that she had been abused by Cotton for the past year. The victim made the allegations to GPD on Thursday, and officers immediately obtains search warrants for Cotton's residence on Holt Street.

While conducting a search of Cotton's computers, images of child porn were found. Cotton was placed in the Geneva County Jail with no bond until his first appearance before a judge.

Morgan said that the Geneva Police Department was assisted by the Alabama Law

Enforcement Agency. "The specialized training that the A.L.E.A. Agents have was very instrumental in closing this case in a very timely manner," Morgan said. He also said that further charges are pending.
