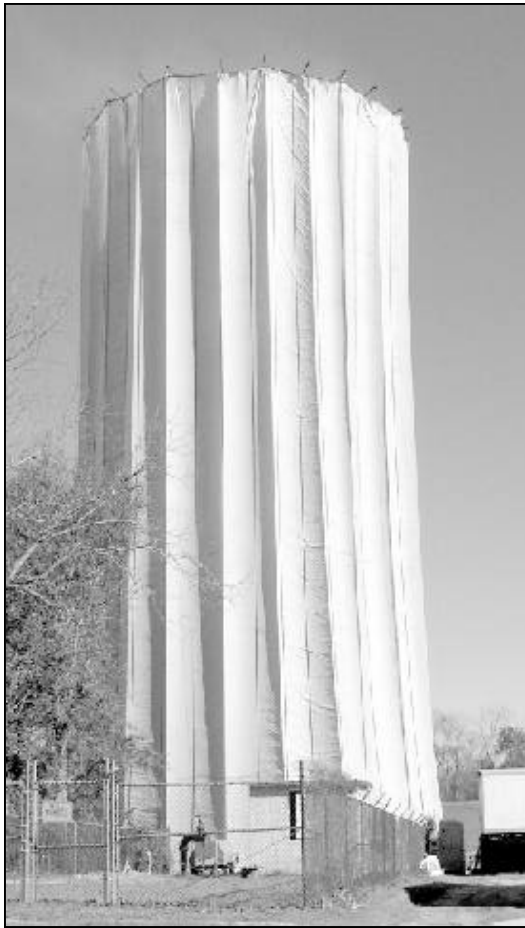

## Bond Amount Cut for Rodgers

John Gilbert Rodgers saw his bond cut from \$400,000 to \$100,000 on Monday, January 30 by Geneva County District Judge Charlie Fleming. The decision leaves the Geneva County District Attorney's office very concerned.

"The victim in this case is a minor and she is obviously frightened of the defendant. The state's main concern is the safety of the minor victim as well as the community as a whole....we will be watching the defendant closely," said Assistant District Attorney Stephen Smith who objected to the bond reduction on behalf of the State.

Rodgers, 64 from the Geneva area, is charged with first degree sexual abuse and three counts of sexual torture to a 15-year-old. He was arrested on

November 8 by Geneva County Drug Task Force Agent Tony Helms and charged with the four felonies.

The definition for first degree sexual abuse is, "subjecting a minor child to sexual contact by forcible compulsion," according to Smith. Smith also stated that Fleming initially ordered a \$400,000 bond for Rodgers when he was charged on November 8, 2005 but reduced it to \$100,000 on Monday.

Rodgers is accused of penetrating the victim with a screwdriver, a small vibrator and a wooden handle of some kind according to Smith. These three things resulted in the three counts of sexual torture which is a Class A felony.

Smith stated that the State is also very concerned about the Defendant being allowed to live within close proximity to the victim's location. The

defendant was ordered not to have any contact with the victim by Judge Fleming according to Smith.

Rodgers is a former corrections officer.
